

On August 28, 2020, this Court convened a status conference with the parties and instructed counsel for Applicant to submit a written update regarding the status of their investigation. On September 3, 2020, counsel for Applicant submitted a Motion for a New or Amended Scheduling Order. On September 16, 2020, counsel for Applicant submitted an Addendum to their Motion for a New or Amended Scheduling Order. On September 21, 2020, Respondent submitted their Response in Opposition to Applicant's Motion for a New or Amended Scheduling Order. On September 28, 2020, counsel for Applicant submitted their Reply to State's Response in Opposition to Applicant's Motion for a New or Amended Scheduling Order.

After hearing from counsel for both parties, this Court issues its Third Amended Scheduling Order as follows:


1. Applicant shall file his *final* Amended PCR Application no later than Tuesday, December the 1st, 2020.
2. Applicant shall complete his discovery by Monday, February the 15th, 2021.
3. Respondent shall complete its discovery by Monday, April the 5th, 2021.



4. The PCR evidentiary hearing is hereby scheduled to begin on or after Monday, July the 19th, 2021, as scheduled by Court Administration.
