for request.

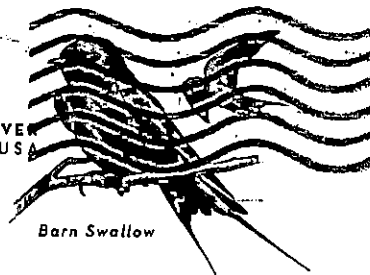
