

NOTICE OF APPEAL

Appellant Louie Weathers appeals the enclosed Order issued by the Honorable Diane S. Goodstein on November 10, 2020. The Honorable Victor G. Stephens originally dismissed Appellant's case in St. George Magistrate Court on January 29, 2020. The State filed a Motion to Reconsider and Reopen on February 4, 2020. Magistrate Judge Stephens subsequently issued an Order denying the State's Motion to Reconsider and Reopen on June 3, 2020. The State appealed to the Dorchester County Court of Common Pleas, and the Honorable Diane S. Goodstein reversed and remanded the Magistrate Judge's ruling in an Order issued on November 10, 2020.
