Dear Mr. Cox:

This responds to your letter dated September 29, 2020. I apologize that a response to this request for an extension was not made earlier.

First, I can find no record that either your or Ms. Floeder are listed as a counsel of record in this case. If you or Ms. Floeder desire to be added as counsel in this case, a notice of appearance will need to be filed with this Court.<sup>1</sup>

Second, Rule 242 of the South Carolina Appellate Court Rules provides for the filing of a petition for a writ of certiorari, a return to the petition for a writ of certiorari and a reply to the return to the petition for a writ of certiorari. In your letter, you apparently seek an extension to file a response to the reply that has been
