2. Counsel for Quincy Lakeith Hemphill respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the


number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the initial brief of appellant and designation of matter in the case of State v. Ricky Manigo Dawson with the Court of Appeals on October 26, 2020. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Dominick Thompson with the Court of Appeals on October 12, 2020. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Gregory Green with the Court of Appeals on September 18, 2020. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Demichael Razor v. State with the Supreme Court on September 11, 2020.




