
MOTION TO FILE AN AMENDED ANDERS BRIEF

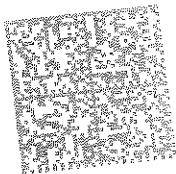

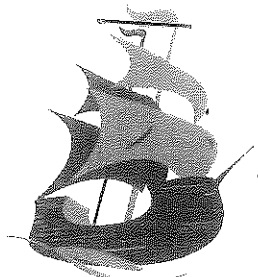
