
MOTION FOR EXTENSION OF TIME TO SERVE AND FILE APPELLANT'S INITIAL

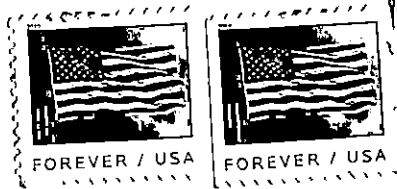
