MOTION TO ORDER TRANSCRIPT OUTSIDE FILING DEADLINES



NOW COMES Appellants Endre and Evan Tomaschek ("Appellants"), by and through their undersigned counsel, and respectfully move the Court for an Order permitting Appellants to order the transcripts from the lower court proceeding outside the deadline specified in Rule 207, SCACR. In support thereof, Appellants show the following:

1. Appellants filed the Notice of Appeal in this case on October 20, 2020.
2. Through the inadvertence of Appellants' counsel, the transcripts from the lower court proceedings were not ordered until November 13, 2020, and correspondence reflecting the ordering of the transcripts was sent to the parties but not to the Clerk of the Court of Appeals.
3. Appellants' counsel requests the Court enter an Order permitting Appellants to order the transcripts from the lower court proceedings outside the deadline provided in Rule 207, SCACR.
4. Because Appellants ordered the transcripts on November 13, 2020, only thirteen days after the time set in Rule 207, SCACR, the grant of Appellants' motion will not result in any appreciable delay in this appeal.
5. Respondent consents to this motion as indicated by the e-mail correspondence attached hereto as Exhibit A.
