NOTICE OF CROSS-APPEAL


NOW COMES, Respondent/Petitioner in the above-captioned Post-Conviction Relief matter, acting by and through his undersigned Counsel, giving notice of his cross-appeal from the Order entered on May 20, 2020. Said order granted Respondent/Petitioner a new trial on some grounds and denied his Application for Post-Conviction Relief on others. Respondent/Petitioner has not included a copy of the May 20, 2020, order as an attachment to the Notice of Cross-Appeal, inasmuch as a copy of that ninety-five page Order, dated May 11, 2020, was previously submitted to the Court with Petitioner/Respondent's Notice of Appeal filed on June 19, 2020.

Petitioner/Respondent subsequently filed a Motion to Alter or Amend said order on June 14, 2020, pursuant to Rule 59 (e), SCRCF. Petitioner/Respondent filed a Notice of Appeal with this Honorable Court on June 19, 2020, from the order filed on May 20, 2020. The Order of the lower court granting a subsequent motion filed by Petitioner/Respondent, asking to withdraw the Motion to Alter or Amend filed in this matter, was filed on October 16, 2020. Counsel for Respondent/Petitioner received that order on Friday, November 29, 2020. Accordingly, Respondent/Petitioner had until November 28, 2020 to serve and file Notice of his Cross-Appeal
