
The Appellant, Travis Glover, by and through his undersigned attorney, moves before this Honorable Court to reopen the case of 2020-001179 and rescind the Court's decision to dismiss this appeal.

1. This Motion is made on the grounds that the Appellant's Appeal was dismissed on October 21, 2020.
2. Specifically that, "Counsel for appellant failed to provide a sufficient guilty plea explanation, as required by Rule 203(d)(1)(B)(iv), of the South Carolina Appellate Court Rules (SCACR), or to forward the explanation to the appellant, as required by the this Court's letters dated September 18, 2020 and October 6, 2020."
3. That on August 31, 2020 Counsel for the Appellant received an email from the South Carolina Court of Appeals stating that the notice of appeal had been received.
4. That on September 1, 2020 Counsel for the Appellant received an email from the South Carolina Court of Appeals stating that counsel needed to provide "a written explanation showing that there is an issue which can be reviewed on appeal."

5. That on September 18, 2020 Counsel for the Appellant received an email from the South Carolina Court of Appeals stating that they received the explanation for the appeal. The letter further stated that the explanation needed to be forwarded to the client, along with a statement that the client has twenty (20) days from the date of the letter to inform the court in writing of any arguable basis that there are issues preserved for appeal.
6. That the South Carolina Court of Appeals as well as the Appellant, Travis Glover, was sent the attached letter along with the explanation on September 25, 2020.
7. That there was no failure to forward the aforementioned explanation to the appellant and the South Carolina Court of Appeals.

NOW, THEREFORE, the Defendant prays for an Order rescinding the Court's decision to dismiss this case and allow for this appeal to be reopened.
