Good afternoon:

I don't recall that Linda North filed anything separately beyond the Probate Court. Petitioners have filed a joint brief in this matter before the Honorable South Carolina Supreme Court. Counsel for Linda North did not appear in the Circuit Court in separate filings, nor did her counsel appear at the hearing which resulted in the Order under review. Petitioners elected to file all papers jointly, both in the Court of Appeals and in this Supreme Court. The positions of Linda and James North appear to be identical in the matter before the Supreme Court.

If Mr. McGrath desires to make a separate argument on behalf of Linda North, then I would respectfully request that the total time allotted for Petitioners' argument be split and that Linda North not be allowed any separate additional time to present what appear to be cumulative arguments on the issues raised and preserved for determination before this Supreme Court.

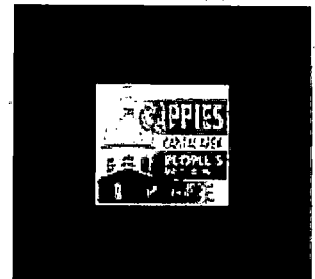
