
Dear Mr. Shearouse:

Appellants-Respondents Duke Energy Carolinas, LLC and Duke Energy Progress, LLC (the “Duke Entities”) submit this letter in accordance with Rule 208(b)(7), SCACR, and in response to the supplemental authority submitted by the Respondent Office of Regulatory Staff (“ORS”).

In addition to the recitation provided by ORS in its letter of December 17, 2020, the underlying orders from the North Carolina Utilities Commission giving rise to *State ex rel. Utilities Comm’n v. Stein*, No. 271A18, 2020 WL 7294770, at *1 (N.C. Dec. 11, 2020) have been cited by the parties to this cross-appeal, and they were exhibits before the Public Service Commission. The Duke Entities further note that the opinion’s finding on page 63 that CAMA was not attributable to an incident at the Duke Energy Carolinas, LLC’s Dan River plant provides supplemental authority on the Duke Entities’ first issue on appeal.
