At a Court of General Sessions, convened on January 21, 2021, the Grand Jurors of York County present upon their oath:

HARASSMENT, FIRST DEGREE

The defendant, Eric Laney, did on or about August 15, 2020, in York County, South Carolina, commit the crime of Harassment, in that the Defendant did engage in a pattern of intentional, substantial, and unreasonable intrusion into the private life of the victim, Stacey Lynne Kelly, causing her or any reasonable person in her position, to suffer mental or emotional distress. The harassment may have included, but was not limited to: following the targeted person as he or she moved from location to location; and/or surveillance of or the maintenance of a presence near the targeted person's residence, school, place or work, or another place regularly occupied or visited by the target person; and/or vandalism or property damage; and/or visual or physical contact that was initiated, maintained, or repeated after the defendant had been provided oral or

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
