Dear Clerk of Court of Appeals:

I am in receipt of your paper dated 12/3/20 which I received on or about 12/8/20. Your paper states the Court has received multiple notices of appeal and that the appeals will be consolidated, and your office anticipates receiving one record on appeal, and the cases consolidated are Grievance No. LEECI-0251-20, LEECI-0338-20, and LEECI-0339-21. However, I filed three separate NOTICE OF APPEALS, and the matter in each appeal differs from the others; two of the cases are denied access to court claims but dealing with two very different cases of calim and may vary in the United States Constitutional provisions and the Staff and circumstances involved regarding each case circumstances vary and their consolidation would confuse the issues, and one of the NOTICE OF APPEALS involves a taking, which is very different than a denied access to court claim. Therefore the matters involved in the Grievances are very different, and being the matters involved these Grievances are very different, consolidation would be inappropriate and confusing to the parties and the Court. I request this Courts action to consolidate be reversed and the cases properly separated, and with anticipation of receiving separate record on appeal for each, in the interest of justice, and to prevent a gross miscarriage of justice, or any other relief as this Court deems just and equitable.

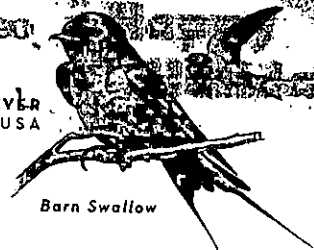
