Appellant/Respondent hereby moves that the Respondent/Appellant's cross-appeal be dismissed on the grounds that the cross-appeal is untimely. Appellant/Respondent filed its Notice of Appeal on June 30, 2020, and Respondent/Appellant Cynthia Holmes ("Holmes") filed her Notice of Cross-Appeal August 4, 2020. On August 14, 2020, Holmes sent a letter to Christine Smith, the court reporter for the Charleston County trial court, requesting transcripts for hearings dated March 10, 2017 and June 16, 2017. A copy of Holmes' correspondence is attached as **Exhibit A**. On October 7, 2020, and in response to a letter from Holmes' counsel requesting an update on the status of the transcript request, Ms. Smith wrote Holmes and informed her that she would resend the requested transcripts, and further noted that she previously sent Holmes the requested transcripts on August 13, 2020. A copy of Ms. Smith's correspondence is attached as **Exhibit B**. On October 17, 2020, Holmes filed a Notice of Receipt of Transcript for Cross-Appeal affirming that Holmes' received the subject transcripts on October 11, 2020. A copy of the Notice is attached as **Exhibit C**.

Pursuant to Rule 208(a)(1), an appellant must serve its initial brief on all parties and file its initial brief with the clerk of the appellate court within thirty days after receiving the transcript. Despite having received the requested transcripts on October 11, 2020, however, Holmes did not serve her initial brief on all parties until November 15, 2020, and the Court did not file the brief until November 16, 2020—four and five days beyond the thirty-day deadline, respectively. Rule 208(a)(4) states that, “[u]pon the failure of the appellant to file and serve his brief within the time prescribed, the clerk of the appellate court shall sign an order dismissing the appeal[.]” Because Holmes failed to timely file her initial brief, her cross-appeal must be dismissed.

CONCLUSION

For these reasons, Appellant/Respondent respectfully requests that the Court dismiss Respondent/Appellant Holmes' cross-appeal. In addition, based on the foregoing, Appellant/Respondent respectfully requests that this Court hold all deadlines, including the deadline for Appellant/Respondent to file its response to Respondent/Appellant's brief, in abeyance pending the resolution of the Motion to Dismiss.




