STATEMENT OF ISSUE ON APPEAL

Whether the court erred in refusing to grant a directed verdict to the charge of intimidation of a court official when appellant had no criminal intent to intimidate a court official?

STATEMENT OF THE CASE

Appellant was convicted of intimidation of a court official and obstruction of justice after a jury trial held before the Honorable John C. Hayes on June 12-16, 2017, in Greenville County. Two 90 month consecutive sentences were imposed. Appellant represented himself at trial. Russell Gent, Esq. was the assistant solicitor.

This appeal follows.

STANDARD OF REVIEW

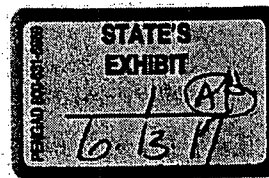
“A case should be submitted to the jury when the evidence is circumstantial ‘if there is any substantial evidence which reasonably tends to prove the guilt of the accused or from which his guilt may be fairly and logically deduced.’” *State v. Bostick*, 392 S.C. 134, 139, 708 S.E.2d 774, 776 (2011) (quoting *State v. Mitchell*, 341 S.C. 406, 409, 535 S.E.2d 126, 127 (2000)).

“Evidence must constitute positive proof of facts and circumstances which reasonably tends to prove guilt.” *Id.* “Unless there is a total failure of competent evidence as to the charges alleged, refusal by the trial judge to direct a verdict of acquittal is not error.” *Id.* at 139, 708 S.E.2d at 776-777. “On appeal of the denial of a directed verdict of acquittal, this Court must look at the evidence in the light most favorable to the state.” *Id.* at 139, 708 S.E.2d at 777; see also *State v. Hepburn*, 406 S.C. 416, 429 753 S.E.2d 402, 409 (2013). If the state failed to present any direct evidence or any substantial circumstantial evidence reasonably tending to prove guilt of the accused, the appellate court must reverse the lower court’s denial of the directed verdict motion. *Hepburn*, 406 S.C. at 416, 429 S.E.2d at 409.

ARGUMENT

The court erred in refusing to grant a directed verdict to the charge of intimidation of a court official when appellant had no criminal intent to intimidate a court official.

The court official that was allegedly intimidated in the case was assistant solicitor Sylvia Harrison in Greenville County. She prosecuted white collar crime cases and was handling appellant's breach of trust case. (R. p. 178, lines 15-24). The investigator on the case was Tim Martin. (R. p. 180, lines 15-16). He passed on an email from appellant to him which was State's Exhibit No. 1. (R. p. 183, lines 8-16). The substance of that email was the following:

THE IMPRECATORY PSALMS

The Imprecatory Psalms (Ps. 35; 52; 55; 58; 59; 79; 109; 137) are cries to God to avenge. Believers in the Word of God explain such invocations of God's vengeance either

(1) on the basis of the progressiveness of revelation (in which such prayers were part of Israel's life prior to the giving of God's full and final revelation); or

(2) by calling attention to such matters as (a) vengeance is placed in God's hands, not the psalmist's (compare Dt. 32:35); (b) it is true that unrepentant and unbelieving sinners must face the terrifying punishment of God; (c) ultimately, it is the honor of God which is at stake, the righteousness of God which must be vindicated (compare Ps. 139:21-22); and (d) the righteous indignation of those who love God is justifiable against injustice, malevolence, lawlessness, and especially against apathy toward or rebellion against Him. God's servants await the day when righteousness will be rewarded and unrighteousness will be punished—in short, the day of the vindication of the moral nature of God (Ps. 72:1-9; Hab. 2:14; Lk. 18:7-8; 1 Cor. 15:25-28; 2 Th. 1:7-10; Rev. 11:17-18; 15:3-4; 19:5-7).

10. Let his children be continually vagabonds, and beg: let them seek their bread also out of their desolate places.

11. Let the extortioner catch all that he hath; and let the strangers spoil his labour.

12. Let there be none to extend mercy unto him: neither let there be any to favour his fatherless children.

110:1 The importance of the 110th Psalm is attested by the remarkable prominence given to it in the N.T.

(1) It affirms the Deity of Jesus, thus answering those who deny the full divine meaning of His N.T. title of Lord (v. 1; Mt. 22:41-45; Mk. 12:35-37; Lk. 20:41-44; Acts 2:34-35; Heb. 1:13; 10:12-13).

(2) It announces the eternal priesthood of Messiah—one of the most important statements of Scripture (v. 4; Gen. 14:18; note; Jn. 14:6; 1 Tim. 2:5-6; Heb. 5:6; note; 7:1-28).

(3) Historically, Ps. 110 begins with the ascension of Christ (v. 1; Jn. 20:17; Acts 7:56; Rev. 3:21). And

(4) prophetically, it looks forward (a) to the time when Christ will appear as the Rod of the LORD's strength, the Deliverer out of Zion (Rom. 11:25-27), and to the conversion of Israel (v. 3; Joel 2:27; Zech. 13:9; see Dt. 30:1-9, and note at v. 3); and (b) to the judgment upon the Gentile powers which precedes the setting up of the kingdom (vv. 5-6; Joel 3:9-17; Zech. 14:1-4; Rev. 19:11-21). See Armageddon (Rev. 16:16; 19:17; note); Israel (Gen. 12:2-3; Rom. 11:26; note); Kingdom (Zech. 12:8; and 1 Cor. 15:24; notes). See Ps. 118; last Messianic Psalm.

She admitted that the Psalm had a box explain what it meant. She testified that she felt intimidated, scared, and threatened. She left town and went to Texas to visit her sister (Tr. p. 189, line 8 – p. 190, line 22).

On cross-examination the assistant solicitor made it clear that appellant did not send her the email. Appellant sent it to Investigator Martin and Martin forwarded it onto her. (Tr. p. 196, lines 11-18; Tr. p. 281, lines 5-19). Psalm 109 was also sent to Investigator Martin. (Tr. p. 358, lines 7-20).

At the conclusion of the State's cases defense counsel moved for a directed verdict which the court denied. (Tr. p. 648, line 5 – p. 649, line 12). That ruling was in error.

Due process as guaranteed by the Fourteenth Amendment requires “that no person shall be made to suffer the onus of a criminal conviction except upon sufficient proof—defined as evidence necessary to convince a trier of fact beyond a reasonable doubt of the existence of every element of the offense.” Jackson v. Virginia, 443 U.S. 307, 316, 99 S.Ct. 2781, 2787 (1979).

Our Court has held:

[T]he trial judge is concerned with the existence or non-existence of evidence, not with its weight; and, although he should not refuse to grant the motion where the evidence merely raises a suspicion that the accused is guilty, it is his duty to submit the case to the jury if there be any substantial evidence which reasonably tends to prove the guilt of the accused, or from which his guilt may be fairly and logically deduced. [Emphasis added].

State v. Littlejohn, 228 S.C. 324, 89 S.E.2d 924, 926 (1955); State v. Edwards, 298 S.C. 272, 379 S.E.2d 888 (1989), cert. denied, 493 U.S. 895, 110 S.Ct. 246 (1989).


In applying this standard, our Court has held that evidence which is “sufficient to raise a strong suspicion of the guilt of the accused” is not sufficient to constitute “any evidence from which the

guilt of the accused may be fairly and logically deduced.” State v. Totherow, 263 S.C. 275, 210 S.E.2d 228, 230 (1974). See, also, State v. Turner, 117 S.C. 470, 109 S.E. 119, 120 (1921). The motion for a directed verdict should be granted, therefore, “where evidence merely raises a suspicion of guilt, or is such to permit the jury to merely conjecture or to speculate as to the accused’s guilt.” State v. Brown, 267 S.C. 311, 227 S.E.2d 674, 677 (1976), citing State v. Matarazzo, 262 S.C. 662, 207 S.E.2d 93, cert. denied, 420 U.S. 945 (1974). “If the evidence is consistent with both innocence and guilt it cannot support a conviction.” United States v. Varoz, 740 F.2d 772, 775 (10th Cir. 1984); United States v. Ortiz, 445 F.2d 1100, 1103 (10th Cir 1971). Guilt is only to be found when there is a “rationally supportable state of near certitude.” Evans-Smith v. Taylor, 19 F.3d 899, 906 (4th Cir 1994).

It is true that appellant sent the email and Psalm 109 to Investigator Martin. But he did not send it to assistant solicitor Sylvia Harrison. While appellant did use some vulgar, crude, and offensive language, he did not intimidate Sylvia Harrison as a court official. Psalm 109 did not even mention her name.

CONCLUSION

A directed verdict should have been granted to the charge of intimation of a court official.


PETITION TO BE RELIEVED AS COUNSEL




