As you see I've enclosed the letter and envelope that I sent out to the TYRCP mail room to be delivered <sup>marked</sup> to you. I couldn't ever get legal paper or envelope. So I did the best I could today the mail room clerk Mr Berry brought some mail to me, and he returned the envelope with the letter; Telling me he could not send that out like that. He brought me legal mail paper & doing marked brief on and the envelope I sent this letter with proof of how I had to do on Dec 23 2020. Its very difficult to do legal work on lockdown.

V. Claire Allen. I didn't receive your December 14, 2020 until Dec 23, 2020 from mail room. Chuck W. Berry here at TYRCI. Also I ~~have~~ have been on lockdown since October 12, 2020 up until Nov 23<sup>rd</sup> for testing positive for covid-19. Then when I was finally cleared, testing negative on the date I was suppose to go back into Inmate Population The Warden put me on lockdown for inappropriate behavior. Based on a write up ~~by~~<sup>by</sup> Nurse Gilmore for violation of SCPL Policy 838 Solicitation of employee, based on a RTSM form 19-11 I wrote to Nurse Gilmore which stated: 'While reviewing a request to staff member form, I read the attached RTSM (SCOC form-19-11) written

by inmate Robert Watkins # 243803. The request  
to staff member read "Dear Beautiful  
Professional Black ~~African~~ African Women.

I appreciate your aid and assistance  
medically, and your medication.

Your presence provide for sore eyes.

Insha Allah may the peace and blessing  
of Allah and his grace and mercy

continued be upon you. [I requested  
the test results that resulted positive  
for Covid 19, these dates of all  
such test. She didn't include that  
in her incident Report J

up on 11-18-2020. When I sent the Warden  
Gadsden, I asked him on Nov 23, 2020  
If I had been <sup>cleared</sup> cleared of Covid 19

Why was I still on lockup for covid-19  
when everyone else has went back to the  
yard. He said he must get with Nurse  
Gilmore to see why. because he thought  
I went back to the yard with everyone else  
that Friday NOV 6, at Mon NOV 9<sup>th</sup> 2020.  
That, it may be out of her hands and Columbia  
must make the call. When I was getting out  
of the shower, Captain Moore and Sergeant Jett  
said they had some bad news, the warden  
Gadsden told them to put me on lockup  
for inappropriate behavior. So I've  
been on lockup since then. I didn't  
received the actual charging paper  
until Dec 15 2020, in which I have served  
22 days already for an offense I had  
not had a hearing for or been convicted  
of. Today is 30 days.

I have been trying to get legal material  
in Kpen, 30 sheets of Paper envelopes.  
I put in RTSm form 19-11 to Mr Berry  
and Ms Robinson ~~two~~ weeks ago for such  
material to due my initial Brief.  
It seem Mr Berry today 12-23-2020, he  
told me that he turned my RTSm to  
Mr Robinson. It is very difficult in getting  
legal material as a indigent defendant of an  
appellate. This is why I asked for an  
extension of time to file my initial Brief  
It is a lockup...

Also you said for me to order the  
transcript, there is no transcript.  
I am not appealing a trial. But I'm  
appealing a motion I filed that was  
denied by the circuit Court judge.
