On December 3, 2020 an Order was issued giving me 15 days from the date of the Order to pay the required filing fee. This puts the deadline for filing on December 18, 2020.

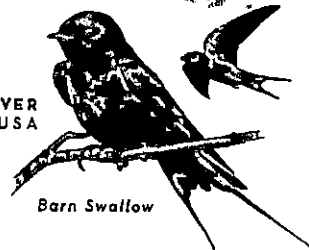
