has had the flu.. I was not late on sending my  
aPeal in. When I received the first letter from the  
state court about being dismissed, I started the Paper  
work then, It was finished by the time the  
Chief Judge sent me his letter. I beleave in one  
of your letters to me you mentioned about a long time  
Period about some dates being stamped and sent to me.  
I was 17 years old when my crime happened and I had  
a death Penalty trial, my civil rights was violated.  
I truly need your help and the Supreme courts help!  
For give me of my writeing and some spelling is bad.

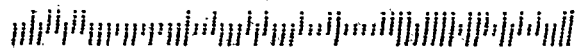
