THE FORGIVENESS DOES NOT APPLY TO A FAILURE OF A PARTY TO TIMELY SERVE THE NOTICE OF APPEAL UNDER RULE 203, 243 AND 247 SCACR.<sup>11</sup>

STATUTE OF LIMITATION.

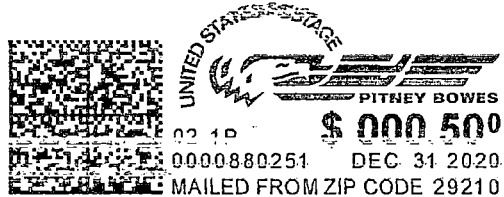
