MOTION FOR AN EXTENSION OF TIME



Counsel filed the Anders brief of appellant and designation of matter in the case of The State v. Frazier Singleton with the Court of Appeals on November 13, 2020.

4. Counsel makes this request in good faith and not for purpose of delay.


