I HAVE BEEN PLACED ON SOLITARY CONFINEMENT AND BEING DENIED ACCESS TO MY LEGAL BOX AND ALL OF MY LEGAL DOCUMENTS. I AM ALSO BEING DENIED ACCESS TO ANY LEGAL BOOKS OR LEGAL WORKING MATERIAL.

I HAVE BEEN HERE ON SOLITARY CONFINEMENT FOR A WEEK CONSTANTLY REQUESTING ACCESS TO MY LEGAL PROPERTY BUT BEING TOTALLY IGNORED BY PERRY C.I. OFFICIALS, SINCE I HAVE NOT RECEIVED ANY RESPONSE FROM MY LEGAL MAIL TO COURTS AND OTHER ATTORNEYS. I CAN'T HELP BUT SUSPECT THAT SCDC IS DELIBERATELY, WILLFULLY, AND INTENTIONALLY WITHHOLDING MY MAIL AND DENYING ME ACCESS TO COURT. I NEED TO HEAR FROM YOU TO VERIFY MY MAIL HAS REACHED YOU. I WILL CONTINUE TO SEND REQUESTS TO YOU UNTIL I RECEIVE YOUR REPLY. THIS FALLS UNDER EXTRA-ORDINARY HARDSHIP CLAUSE TO PROTECT MY CASE FROM DISMISSAL ORDER.
