This has become detrimental to my physical and mental well being. I am 50 years old and need to get back home to my team of doctors.

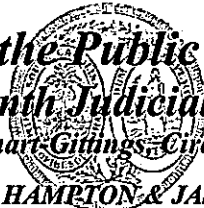
