
Motion for extension of time to complete Record of Appeal

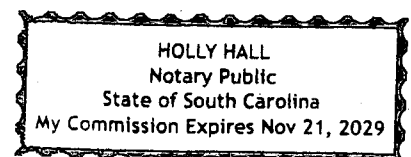
