I have received your letter dated April 19, 2017 in which you have notified me that there are two convictions for cocaine possession in 2004. I do remember handling the convictions and the plea agreement was that they would be consolidated and merged as only one charge and conviction. This was the agreement and if you notice on my NCIC report there is only one conviction from 2004. Also, if you would notice my City & County Background report you will find that there is only one conviction. Note also that the charge is over ten years old and it should not be used as an enhancer. I have read your letter and my main focus is on the trafficking charge. All of the charges allow for parole except for the trafficking charge.

Only trafficking 1st Offense is parolable. I seek to have the trafficking charge dismissed. At that ~~point~~ point, at least, I will be eligible for parole. Even if I were sentenced to trafficking 1st and sentenced to the maximum sentence that it carries which is ten years, I would still be eligible for parole. It's not right, and I know that they know that it's not right, but I would not further pursue any ineffective assistance claim.

The allegation that there are two possession of cocaine charges on my record other than them being consolidated and merged as one charge, I haven't had the opportunity to address that in PCR, so therefore it leaves a reason for a Rule 59(a)(2) motion to be filed for a new PCR hearing so that I have the opportunity to address the issue.

I certainly do look forward to hearing from you soon.



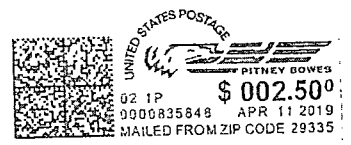
