
1. Appellant’s counsel changed firms on July 31, 2020. The requested amendments are non-substantive and consist only of updates to Appellant’s counsel’s firm information.



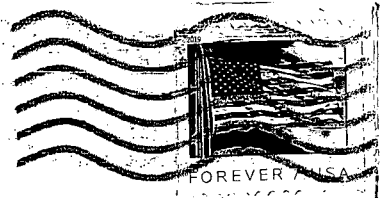
