**MOTION FOR THIRD EXTENSION OF TIME WITHIN WHICH  
TO SERVE AND FILE INITIAL BRIEF OF RESPONDENT  
AND DESIGNATION OF MATTER**

Respondent (“the State”), through its undersigned counsel, would respectfully show unto the Court as follows:

**I.**

The Initial Brief of Respondent and Designation of Matter are due to be served and filed on March 3, 2021.

**II.**

Pursuant to RE: Extension Requests in Criminal Direct Appeals and Post-Conviction Relief Certiorari Proceedings: Order of the South Carolina Supreme Court dated March 18, 2009, the State moves for a **third** extension in the above-referenced criminal appeal and asks for an additional thirty days to complete the brief in this case. In the past few weeks and months, the undersigned counsel participated in oral argument at the Supreme Court in State v. Joseph

Bowers and State v. William D. Lewis; has participated in oral argument at the Court of Appeals in State v. Adam Keith Lunsford, State v. Robert Lee Miller, III, State v. Darrell Oneil Boston, and State v. Gregg Pickrell; has submitted an Initial Brief of Respondent to the Supreme Court in State v. William D. Lewis; has submitted and Initial Brief of Respondent to the Court of Appeals in State v. Shi Heme Raquan Price, State v. Elizabeth Leanne Howze, and State v. Charles Davenport, Jr.; has submitted a Return to Petition for Writ of Certiorari to the Supreme Court in State v. Kenneth Strothers Collins, State v. Michael N. Frasier, Jr., and Justin Ryan Hillerby v. State; has submitted a Return to Petition for Writ of Certiorari to the Court of Appeals in George Napoleon Moses v. State; and has submitted a Petition for Rehearing to the Court of Appeals in State v. Randy Wright.

### III.

The undersigned counsel submits this extension request is supported by good cause and is not intended for purposes of delay. To date, the undersigned counsel has been unable to complete the Brief in this case due to work required in other cases along with his other responsibilities in the office. Beyond that, the Brief in the above-referenced case has required significant research because the case involves both a claim of a violation of a constitutional right and a multi-pronged attack to the trial judge's denial of a directed verdict motion. The undersigned counsel is currently working on the Brief in this case and intends to have it finished in a timely manner. However, the undersigned counsel has not yet been able to finish the Brief. Accordingly, in order to ensure the Brief is properly researched and prepared, I would therefore request an additional extension of time within which to serve and file the Brief.



from the date such relief is granted; hold the matter in abeyance pending a ruling on Respondent's motion; and grant such other and further relief as the Court may deem just and proper.


