MOTION TO EXTEND TIME TO FILE RESPONDENT'S BRIEF

Respondent 1250 Old Gilliard Road, LLC submits this Motion to Extend Time to File Respondent's Brief to request an extension to file its Initial Brief in this appeal.

The grounds for this Motion include, but are not limited to:

1. Although Appellant filed his Initial Brief with this Court on January 25, 2021, he did not serve Respondent with the brief in accordance with Rule 208(a) of the South Carolina Appellate Court Rules. Respondent has just been made aware of the filing of the brief; and
2. A reasonable extension of time would enable counsel and Respondent to prepare and communicate about the brief more thoroughly in order to facilitate the Court's review

This is Respondent's first request for an extension in this matter. Should the Court grant the requested extension, the briefing and Record on Appeal deadlines would be extended accordingly.
