I hope this finds you in good health and doing well. I represent Expedia, Inc. (incorrectly denominated by the Appellant as "Expedia") (hereinafter "Expedia") in connection with the above-referenced case.

As I discussed with Ms. Spencer on February 24, 2021, it appears the Appellant omitted some pages from the Record On Appeal. In particular, Expedia does not see an affidavit it identified in its Designation Of Matter To Be Included In The Record On Appeal. Based on the fact the affidavit is identified in Appellant's Index, it appears the omission is inadvertent.

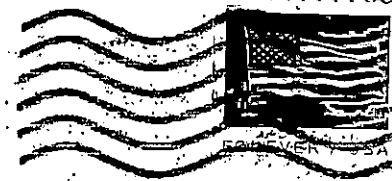
