NOTICE OF APPEAL

Concord & Cumberland HPR (“HPR”) appeals the following orders of the Honorable Deadra L. Jefferson and, by necessity, the order of the Honorable Mikell R. Scarborough:

- Order on Motion to Lift Stay and Motions to Vacate or Correct Arbitration Award, filed January 30, 2020 (Exhibit A);
- Order on Concord & Cumberland HPR’s Motion to Alter/Amend, filed May 1, 2020 (Exhibit B); and
- Order Confirming Arbitration Award, filed February 16, 2021 (Exhibit C).

The HPR previously appealed the above referenced orders by Judge Jefferson, filed January 30, 2020, and May 1, 2020, in Appellate Case No. 2020-000875. This Court dismissed the appeal as premature pending confirmation of the award. Judge Scarborough confirmed the underlying arbitration award on February 26, 2021, and this appeal is now ripe and timely. Copies of the appealed orders are attached hereto and incorporated herein by reference.
