MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for Jerry Whitfield respectfully requests an extension of a **final thirty (30) days until May 1, 2013**, in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix is due to be served and filed with the Court on **April 1, 2013**.



4. Counsel makes this request in good faith and not for purpose of delay.


5. As indicated by signature below, John Walt Whitmire, of the South Carolina Attorney General's Office, does not oppose this request.


