Dear S.C. Supreme Court:

I am in receipt of your paper dated March 04, 2021 which I received sometime after that date but before today. Your paper states it received my 2/23/21 motion seeking extension of time to file petition for writ of certiorari to review the S.C. Court of Appeals decision of case number 2020-001658. Your paper also states that remittitur was sent 1/28/21 and that the remittitur ended appellate jurisdiction over this case and that no further petition can be considered by either appellate court, citations for Stogsdill, and Wise. And that no action will be taken on my motion for extension of time. However, I filed for petition for rehearing on 1/29/21 within 15 days of S.C. Court of Appeals notice on 1/25/21 of ORDER of 1/6/21.

South Carolina Appellate Court Rule 242(c) clearly reads "A petition for writ of certiorari shall be served with the Clerk of the Court of Appeals and the Clerk of the Supreme Court within thirty (30) days after the petition for rehearing or reinstatement is finally decided by the Court of Appeals", I was notified of S.C. Court of Appeal 1/6/21 ORDER on 1/25/21 and I filed Motion for Extension of Time 2/23/21 which is well within 30 days of when I received notice of the S.C. Court of Appeal ORDER.

I am experiencing great difficulty attending the prison law library, and the non-treatment of my serious medical condition by prison is diminishing my ability to function and diminishing my health and causing me needless pain and suffering. The prison law library hours have been cut to a maximum half of what it was previously and was closed all this week to me. I need the library to do my papers.

PEMISES CONSIDERED, I request this case to be instated--or reinstated--and extra time to file petition for writ of certiorari to this Court, I request an extra 30 days, and any other relief as this Court deems fit and appropriate.

I certify that I have served this Motion to Reinstate upon all parties to this action by placing the same in the prison mail system addressed to their last known address on this day.

I declare under penalty of perjury the foregoing is true and correct.
