**On November 05, 2020 I asked about the extention of time to serve the record on appeal. I can not find the information when this extention will expires.**



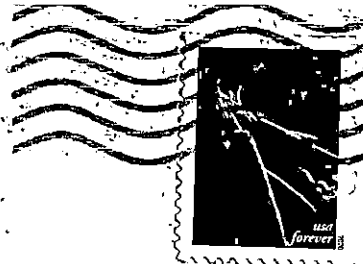
