

SUPREME COURT IS IN THE MIDST OF HEARING THIS SAME IDENTICAL ISSUE AND CONCERN UNDER CASE 2020-001615, WHERE THE S.C. ATTORNEY GENERAL IS ALSO PARTY, INVOKING THE S.C. SUPREME COURT'S ORIGINAL JURISDICTION. THUS, THE S.C. SUPREME COURT'S JURISDICTION TO ADDRESS THESE IDENTICAL MATTERS SUPERSEDES THE S.C. COURT OF APPEALS IN THIS INSTANCE. THE ISSUE PRESENTED BEFORE BOTH COURTS IS, IS THE LOWER COMMON PLEAS COURT(S) JURISDICTION MADE VOID DUE TO THE COURTS GOING BEYOND THE (365) DAY DUE PROCESS MANDATE ATTACHED TO THE S.C. CONSTITUTION SET IN PLACE BY THE S.C. LEGISLATURE MAKING ANY ORDER ATTEMPTED TO BE FILED BY THE LOWER COURTS A FINAL ORDER DUE TO THE ATTEMPTS TO SUBMIT AND OR FILE IT AFTER AND OR WHEN THE LOWER COURTS JURISDICTION IS MADE VOID DUE TO THE UNCONSTITUTIONAL ACTION, AND NO SUCH ORDERS OF ANY KIND CAN THEREUPON BE SUBMITTED, WHICH WOULD DEEM THAT SUCH ORDERS MUST BE CONSTRUED AS FINAL AND APPEALABLE?

TO INCLUDE THE VERY FACT THAT THE S.C. ATTORNEY GENERAL ALREADY DEFAULTED ON THIS EXACT SAME ISSUE UNDER CASE 2019-CP-08-1992 WHICH IS THE SOURCE OF THE APPEAL UNDER CASE 2020-001615. IF THE COURT IS VOID OF JURISDICTION DUE TO UNCONSTITUTIONAL ACTION AND THE SUBMITTING OF SUCH ORDERS VIOLATE THE SEPARATION OF POWERS CLAUSE? THEN SUCH ORDERS, THOUGH NORMALLY ARE NOT FINAL, MUST BE DEEMED FINAL UNDER THESE CIRCUMSTANCES AND FOR APPEAL PURPOSES.

THE APPELLANT MOTIONS FOR A REHEARING AND MOTION TO STAY ANY TIME OF REHEARING AND RULING THEREUPON, UNTIL THE S.C. SUPREME COURT RULES ON THESE SAME EXACT IDENTICAL ISSUES OF CONCERN WHERE THE S.C. ATTORNEY GENERAL IS PARTY IN BOTH THESE CASES AND ALREADY DEFAULTED ON THE CLAIMS WHICH WOULD THEN ALLOW THE APPELLANT TO ASSERT THE DUE PROCESS RIGHT OF NON PARTY COLLATERAL ESTOPPEL AS IT RELATES TO ISSUE PRECLUSION ADDRESSING THESE IDENTICAL MATTERS. 
