Dear Ms. Kitchens:

Claire Allen has been kind enough to write me again about the transcript in this appeal, as she did on February 11, 2021.

I relate again, as I did in February, that no transcript has been received. We have no idea who the court reporter was for the hearing, as reflected in my original transcript order of June 8, 2020. A copy of that letter is attached.

The court website did not identify who the reporter was for the hearing, listing only "Circuit Court DCRP" as the reporter identifier. Consequently, to order the transcript when I noticed the appeal, the best I could do was to write to court administration, explain the vague designation, and requested the transcript through court administration. That was June 8, 2020.

On February 11, 2021 the Court of Appeals also inquired about the transcript. When we explained the issue I understood the problem would be corrected and transcript would be ordered. I have never been given any information about the court reporter's identity or if the transcript was indeed ordered in February after I had tried to order it June 8, 2020.

So we remain where we have been since June 8, 2020, which is awaiting the transcript. We can brief this case promptly upon receiving it, but we cannot brief it without receiving it.

Any assistance on this transcript conundrum would be appreciated. Without knowing who the court reporter was, I cannot myself request any updates on the transcript production.
