This appeal is based upon the record of the proceeding filed in this case, applicable rules of Court and such other matters as may be properly presented to the Court.



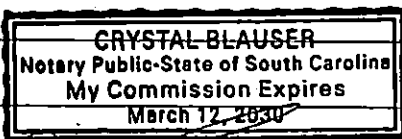


