
Dear Hon. Shearouse:

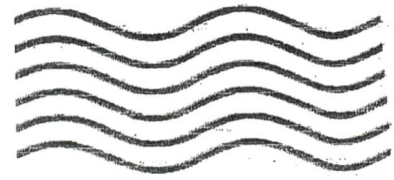
