Dear Mr. Shearouse Clerk of Court:

I am responding to a letter I received from your office April 15, 2021, a letter written to the court by Brenda Bradley relating to the above case, since I haven't seen the letter I will do my best to respond.

As the case number above is pending and under the consideration of this court, I would like to remind the court that the property relating to this case have been auctioned due to delinquent payment of property taxes, in the amount of \$17,722.94. I Diane LaPrade have been the sole payer for the property taxes for the prior 10 years. I have also been the sole redeemer of this property 3 times throughout those 10 years and should be the sole owner of the property due to the redemption laws which I am asking the court to review and to find favor in this matter and to awards damages I suffered!

I would also like for the court to consider the hundreds of notices sent to the defendants named in this case for years, in a variety of ways such as but not limited to: certified letters, emails, phone calls, texts, word of mouth, signs hanging on the property letting everyone know that taxes were due and the property would be taken if these taxes were not paid and they refused to pay the bill or respond accept for me. The defendants were also contacted by a prior lawyer I hired, guardian ad litem, sheriff office, county tax office, ad in the newspaper for 980.00 etc. that I had to pay for. I even asked the judge for justice while standing in court to make them pay the taxes before it got to this court because the case was not settled, everyone knew this property would go to auction if the bill did not get paid and they didn't care. This time I didn't pay the bill because of their continued unjust gain and unjust enrichment off of the Plaintiff. They continue to capitalize off my pain and suffering as it relates to this property and the proof that they didn't care is evident because out of over 11 people they refused to pay the bill yet again knowing the property would be auctioned. And this time I didn't pay the bill and

the results are clear, the property is auctioned. I am the only one willing to redeem it again but I can't until this suit is quieted and they no longer possess a threat.

Everything done for this property was at expense of the plaintiff. And the defendants violated and abused the plaintiff's rights. They never contributed anything toward the cause 'property gain after slavery' or any type of financial contribution. They are operating under the same standards of today's illegal and hostile squatters, benefits with no payments for 24 years...


