Dear Mr. Bailey,

I hope this letter finds you well. In the week following your guilty plea of March 24, 2021, I received messages from you and Gloria Jones, indicating you wished for me to file an appeal of your sentence. Our office filed that appeal within the 10 day time frame, and by now you should have received the copy that my paralegal mailed to you at the jail. I am writing at this time to explain the next step in the appeal of your sentence.

Pleased find enclosed a copy of a letter I received from the South Carolina Court of Appeals in response. I am required to send you a copy of this letter within 10 days of receiving it. It is now your turn to act. You must write to the court directly, explaining your reasons for wanting an appeal.

You have twenty (20) days from the date of this letter to send your response to the South Carolina Court of Appeals, P.O. Box 11629, Columbia, SC 29211. If the court does not hear from you, they will dismiss your appeal.

I anticipated that you would have been transferred from Alvin S. Glenn to Kirkland Reception and Evaluation by now, and I am not certain why this hasn't happened. I double-checked that the paperwork was sent to the jail and you have no other matters pending in Richland County. I will put a reminder in my calendar to check that your jail credit is properly applied once you do reach SCDC.
