I HAVE BEEN ADVISED WHEN THE SUPREME COURT RENDERS A DECISION IN THIS MATTER I WILL BE NOTIFIED - BUT - BEFORE THE COURT, SHOULD REVIEW ANY ADDITIONAL COMPLAINTS FOR RELIEF.
