
I am writing in response to Mr. Meyers' letter to you of March 26, 2013. As Mr. Meyers accurately states, the Court has given its "assurance that the Court would hear the appeal in the above-entitled case, which is to be argued April 4, solely on the briefs and record." That really should have been the end of Mr. Meyers' communication with the Court.

Instead, Mr. Meyers engages in a four page, single spaced argument in which he transparently attempts to reargue his position that there was "attorney misconduct" and "collusion" in the class action matter that is at issue. Indeed, Mr. Meyers' letter is nothing more than a thinly veiled second reply brief, to which we do not intend to respond.

We agree with Mr. Meyers that nothing contained in the materials pertaining to Mr. Flowers is pertinent in tomorrow's argument or in the disposition of this case. We trust and find sufficient the Court's assurance that such materials will play no role in the disposition of this matter. We only wish that Mr. Meyers had accepted the Court's assurance and resisted the temptation to re-state his argument once again.

We respectfully request that the Court disregard Mr. Meyer's letter.
