APPELLANTS' INITIAL BRIEF**


The Appellant move this Court for an Order for an Extension of time to file the



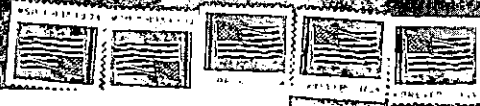
