
1. The Initial Brief of Appellant and Designation of Matter in the above-captioned case were filed with the Court on July 13, 2020. The Initial Brief of Respondent and Designation of Matter were filed with this Court on February 12, 2021. The Initial Reply Brief of Appellant was filed with this Court on March 25, 2021. The Record on Appeal was filed with this Court on April 26, 2021. The Final Brief of Appellant and Final Reply Brief of Appellant are due to be filed with this Court on May 17, 2021.

While preparing the final brief, Counsel discovered that the South Carolina Department of Corrections (SCDC) inmate search detail reports, regarding co-defendants McKinley Lee Daniels and James Elbert Daniels, Jr., referenced on page 4, n.1 of the brief of appellant were missing from the Record on Appeal because counsel inadvertently failed to designate them in his initial brief and designation.

4. Appellant is consequently, today, May 7, 2021, filing a supplemental record on appeal, in order to include the SCDC inmate search detail reports for McKinley Daniels and James Elbert Daniels, Jr.

5. Opposing counsel, William Edgar Salter, III, generously consents to having the SCDC inmate search detail reports for McKinley Daniels and James Elbert Daniels, Jr., included in the supplemental record on appeal as requested in this petition.


