RESPONDENTS’ JOINT RETURN TO THE APPELLANT’S MOTION TO STRIKE

Respondents Stephen Dudek, Doreen Cross, Allison Williams, First Federal¹, Michael Scarafile, Susan Nicholson, Carolina One Real Estate, Carrie Boyer, and Woody Law Firm (herein collectively the “Respondents”) respectfully submit this return to the Appellant’s motion to strike the Respondents’ motion to dismiss, which the Respondents filed on or about April 8, 2021. The Appellant’s motion to strike is no more than an untimely return to the Respondents’ motion to dismiss. The Appellant did not file a return the Respondents’ motion to dismiss and is now attempting to get around the deadline by captioning her return as a motion to strike.
