This letter is to request a twenty day extension of time to file the Final Brief of Respondents State Fiscal Accountability Authority and South Carolina Insurance Reserve Fund in the above reference matter. This extension is needed because of issues that have arisen with the Record on Appeal as presently prepared and served. Specifically, it appears that the wrong Plaintiff's Motion for Summary Judgment was designated and included in the Record on Appeal.
