MOTION FOR AN EXTENSION TO FILE
THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Jamaal Hinson respectfully requests a **final thirty (30) day extension, until June 11, 2021**, in which to file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today. The Court has granted counsel two previous extensions.

2. Counsel for Jamaal Hinson respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.


3. On May 6, 2021, counsel filed the petition for writ of certiorari and accompanying appendix in Jamie L. Giles v. The State with the Supreme Court. On April 23, 2021, counsel filed the initial brief of appellant and designation of matter in The State v. Lutavious Denard Elmore with the Court of Appeals. On April 13, 2021, counsel had an oral argument in The State v. Shane Washington before the Supreme Court. On March 22, 2021, counsel filed the brief of petitioner in Gene Tony Cooper v. The State with the Court of Appeals. On March 15, 2021, counsel filed the initial brief of appellant and designation of matter in The State v. David Viron Lewis Garrett with the Court of Appeals.

4. Counsel makes this request in good faith and not for purpose of delay.


5. On April 29, 2021, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through May 31, 2021.
