When I got to R&E They never took my DNA. Because the officers told me that something was wrong with my paperwork? Even though I went to trial the same asst. Public def. MB McMillan asked me in the courtroom did I want to appeal this decision I told him you Damn right I do so he told me and my mother that he was gonna get his asst. to draw up the papers the same day and he going to file within the 10 days we had to get it done. the trial was on the 8th of July he didn't file it until Aug. 19th?? on purpose. So the court dismissed it for untimely file. I reported him to the disciplinary counsel for the nothing happen to him. he could have got disbarred for his actions. But after the farce of a trial I had Judge Early told him (you will be protected)?? Its in the transcripts also. I will skip ahead and get to the point im writing you about. Nov. 19 2017 while I was at Perry (a yard I was not supposed to be on) It was for 40 and over with life sentences. I was stabbed 5 times a nearly killed for nothing

I recently found out that a person in prison has 2 yrs to take legal action so I had until Nov. 19th 2019 to take action in which I didn't because I was stuck on lockup most of this time to heal from my wounds and in this time the officers was reading my mail and making sure I didn't get a lawyer to sue them I even wrote General Council and they made copies and I have copies to prove this. In March of 2019 I was attacked by 6 inmates at Broad River (another yard I wasn't supposed to be on being a level 2) I got my jaw broken in 2 places because of a lock in a sock. I had surgery but I jaw and teeth will never be the same. The 2 yrs for this lawsuit ended March of this year. Sir can I please go home now?? I have committed no crime whatsoever and I've been in here 6 yr for nothing. The last order I got from your court says that Stephanie P McDonald after careful consideration denied my motion to relieve counsel. Who is she? Is she a Judge, Deputy Clerk Clerk? Is this order legit? Why didn't

you sign it? Like all the rest of the orders a Judge or somebody official always sign an order. And my Appellate Defender Ms. Susan B Hackett chose not sign her name as well. This is why I've enclosed a copy of the order and letter from Ms. Hackett. Something does not seem ~~right~~ right about this because Ms. Jenny ABBOTT Kitching or Ms V Clair Allen and Ms. Hackett always sign their own names on everything I gotten from them. Thank you Sir for taking the time to read my cry for help out of here.



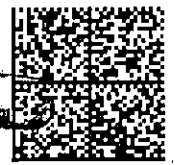
