# Motion For Substitution of Attorney



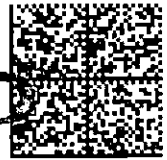
