

DESCRIPTION OF OFFENSE: Criminal sexual conduct with minor, 3rd degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about November 2, 2017 while at 7648 Gamers Ferry Road Apt. 171, Columbia, SC 29209 in the Lykesland Magisterial District of Richland County, it is believed that the defendant did commit the crime of criminal sexual conduct with a minor 3rd degree - 16-3-655 (C). It is believed the defendant committed the crime because the defendant did willfully commit a lewd and lascivious act upon a 13 year old female, Indyia O (DOB 02/14/2004) in that while she was sleeping, he did touch the victim about her vagina area over her jeans. The victim woke up and caught the defendant in the act. The victim supplied law enforcement a written sworn statement implicating and identifying the defendant. Two witnesses have supplied sworn statements that the defendant did go upstairs to the area where the victim was sleeping at the time of the incident.
