**MOTION FOR EXTENSION OF TIME TO FILE AMENDED NOTICE OF  
APPEAL**

Pursuant to Rule 263(b), SCACR, counsel for Appellants-Respondents, hereby move for an additional thirty (30) day extension of time in which to file their Amended Notice of Appeal. On or about December 9, 2020, Respondent-Appellant filed a motion to hold Appellants-Respondents' Notice of Appeal and Respondent-Appellant's Notice of Cross-Appeal in abeyance pending resolution of the Appellants-Respondents' Rule 59 motion to Judge Jackson. At that time, both initial briefs had been filed with this court. On or about February 4, 2021, this Court granted Respondent-Appellant's motion to hold the appeal in abeyance and remanded the matter for consideration of the pending Rule 59(e), SCRCF, motion. This court further requested that Respondent-Appellant provide this court with status updates every thirty days until the master-in-equity resolved the pending motion. On or about March 4, 2021, this court amended this order to clarify that the appeal

and cross-appeal shall be held in abeyance pending the master-in-equity's consideration of the pending motion. On or about March 8, 2021, the master-in-equity denied the Rule 59(e), indicating a formal order was to follow. To date, there is only the Form 4 order. *See* Ex. A. In the abundance of caution, Appellants-Respondents' seek additional time to file their Amended Notice of Appeal to incorporate the lower court's Rule 59(e) denial. The Amended Notice of Appeal is filed contemporaneously with this motion.
